

Accomplishments of the College in 2012

2012 Futures Conference: The College hosted the fourth annual Futures Conference which had the largest attendance to date. Sixty-six Fellows and 45 law practice management professionals from around the world attended. Eight sessions were presented on a myriad of topics focused on the future of law practice management. For the second year, the College addressed the issue of value -- how to define and the trend towards alternative fee arrangements. We also heard from Managing Partners about how the future is dictating a new focus in law firm management and from law firms that are breaking the mold. Sessions were inspiring and discussions spirited.

InnovAction Awards: Now in its eighth year, the InnovAction Awards program continues to celebrate and recognize innovation in the delivery of legal services. We received 10 entries this year which were judged on four primary criteria: *Originality, Disruption, Value* and *Effectiveness*. From these entries the judges selected two winners: Seyfarth Shaw LLP for its *SeyfarthLean* program; and Littler Mendelson for Littler CaseSmart™. Representatives from both winning organizations attended the Futures Conference and awards presentation. In 2012 we welcomed a new face to the judging panel. Joining judges Tom Clay, Merrilyn Astin Tarlton, Tony Williams and Ida Abbott was Patrick Lamb. Many thanks to Maggie Callicrate who rotated off the panel in 2012.

Legal Aid Service Project: Momentum for the Legal Aid Service Project continues to grow. College Fellows participated in site visits of LSC grantee programs in Virginia (Rob Rubenstein), New Hampshire (J. Larry Greene), Ohio (John Kirk), New York (J. Larry Greene) and New Jersey (James Wilbur). Additionally, Joel Rose presented a succession planning workshop to LSC Team Leaders in Washington, and Mark Robertson worked directly with the Northern Mississippi legal aid office on strategic planning. After a presentation by new Fellow, Jim Sandman at the Futures Conference attendees held an enthusiastic discussion about how the College can expand their service to the Legal Services Corporation. Stay tuned for some new opportunities in 2013.

College Finances: The College operates with limited funds and a part-time administrator. It has been exciting to add new programs like the Futures Conference and the Legal Aid Service Project without increasing annual Fellow dues. Unfortunately, Fellow dues and induction fees fail to cover administrative expenses. Last March, the Trustees decided to increase the cost of the Futures Conference/Annual Meeting registration for the first time since 2007 and committed volunteers worked hard on College sponsorships. This change had a sizable impact on the bottom line enabling us to replenish some of our reserves.
